Remote Learning

Overview

The following applies only in the event of a whole school closure.

The immediate focus is to ensure continuity of learning. There are a number of ways in which the College can make alternative arrangements to assist students with their learning and enable them to demonstrate unit outcomes and be engaged in assessment activities.

VCAA are taking a flexible and agile approach to meeting emerging issues and is relying on schools to be similarly flexible and agile in ensuring continuity of learning and delivery of assessment.

Remote learning means that each student can access their lesson materials remotely. This is facilitated online through their SIMON student portal and/or access to class resources made available through Google Classrooms, Education Perfect or other digital platforms typically accessed in your subject class. This will allow each student the ability to participate in their timetabled classes from home.

Remote learning means that each students lesson instructions, materials and reference to the textbooks will be made available online. The work set for each class will reflect the same amount of work that each student would receive if they were attending classes onsite.

Lesson outlines will be made available in SIMON, on the Class Notices page, by 9.00am each morning.

Additional resources to support student learning may be uploaded to the General documents section for downloading.

One class work task will be set to be uploaded each lesson for the duration of the school closure. This will allow teachers to monitor class work and attendance at the same time.

It is expected that staff will continually check their email across the course of the day and provide prompt feedback between the hours of 9:00am and 4.00pm.

Normal school holiday dates will remain.

Staff and Student Expectation Years 7 - 10

With regard to the remote learning management system, it is expected that staff will:

- use the existing online learning management systems SIMON, to share learning and teaching resources and materials
- provide materials to students via email, EDUCATION PERFECT and rescheduling classroom activities and/or assessment tasks. If required, provide access via USB or hard copy of textbook to guide the individual learning program

With regard to the remote learning coursework, it is expected that staff will:

- re-order some of the learning program for studies with a practical component
- ensure that the quantity of work provided for learning is consistent with the structure of the timetable as students will be using the current timetable as a structural plan for working remotely
- ensure that work given to students has a task component (e.g. class task) which can be emailed to subject teachers as evidence e.g. Students complete reading pages 4-6 of set text and answer questions which are returned to teachers via upload option on SIMON or as a GOOGLE CLASSROOM/DOC to avoid possible inbox storage issues on email.

With regard to the differentiation of coursework, it is expected that staff will:

- set substitute task(s) of the same type where possible
- consider the differentiation booklet found in knowledge banks (other resources) on SIMON when considering remote tasks for student learning
- provide access to work for students that is differentiated to known academic levels
- ensure that when creating class tasks that parent accessibility is ticked in the task creation process to allow for parents to monitor student work remotely

With regard to the assessment tasks, it is expected that staff will:

- allow students extra time to complete work or an assessment task
- use a planned task to assess more outcomes, or replace a task with a different type than originally planned
- provide feedback to students during this period of time. This may be done via, written report, rubric, video, forum, whole class or individual.

It is expected that students will:

- be prepared for learning to take place remotely by taking materials home and communicating with teachers if hard copies of work are required prior to school closure, especially if there are internet constraints in the student's home
- maintain consolidation of learning at home for the current area of study in every enrolled subject completing tasks as set on SIMON by due dates.
- Make time to complete tasks during normal school hours and be available to communicate via email during normal school hours if internet access permits. Students need to manage their learning whilst at home using their normal timetable to structure their day(s) off campus.
- inform subject teacher as soon as possible via email if a task is unable to be completed

Staff and Student Expectation VCE/VCAL/VET

With regard to the remote learning management system, it is expected that staff will:

- use the existing online learning management systems SIMON, to share learning and teaching resources and materials
- provide materials to students via email, EDROLO, USB or hard copy of textbook to guide the individual learning program where required
- re-order of the learning program for studies with a practical component
- in the instance that a GOOGLE platform is used, provide an email with GOOGLE access links to online tasks for evidence to relevant Sub-school directors

With regard to the remote learning coursework, it is expected that staff will:

- set a substitute task of the same type
- ensure that work given to students has a task component (e.g. class task) which can be emailed to subject teachers as evidence e.g. Students complete reading pages 4-6 of set text and answer questions which are returned to teachers via upload option on SIMON or as a GOOGLE CLASSROOM/DOC to avoid possible inbox storage issues on email.
- ensure that when creating class tasks that Parent accessibility is ticked in the task creation process to allow for parents to monitor student work remotely
- provide feedback to students during this period of time. This may be done via written report, rubric, video, forum, whole class or individual.

With regard to the assessment tasks, it is expected that staff will:

- reschedule classroom activities and/or assessment tasks.
- allow students extra time to complete work or an assessment task
- use a planned task to assess more outcomes, replace a task with a different type than originally planned
- consider deriving satisfactory completion of outcomes or scores from other assessments or work completed by the student
- consider special provisions granted to students when preparing VCE tasks, if staff are unclear please communicate with VCE coordinator ADMIN

It is expected that VCE students will be:

- aware of and prepared for learning to take place remotely by taking materials home and communicating with teachers if hard copies of work is required prior to school closure
- To maintain consolidation of learning at home for the current area of study in every enrolled subject completing tasks as set on SIMON by due dates.
- completing tasks during normal school hours and be available to communicate via email during normal school hours if internet access permits
- Understand that whilst the school closure is at a Local level that efforts by students must be made to keep up to date with work as current VCAA dates for GAT and exams still stand until official notification otherwise

It is expected that VCAL students will be:

- aware of and prepared for learning to take place remotely by taking materials home and communicating with teachers if hard copies of work is required prior to school closure
- maintain consolidation of learning at home for the current area of study in every enrolled subject completing tasks as set on SIMON by due dates
- aware that work placements and offsite TAFE is suspended until further notice

Parent Expectations

Parents are asked to:

- become familiar with PAM (parent access module) and can request access codes from college office
- support their child in the establishment of a daily routine timetable which mirrors the student's timetable
- where possible put in place measures to monitor their child's online activity during the school day to ensure that set tasks are accessible and that the student has attempted to complete tasks

Setting up for remote learning

Within your designated work area it is recommended that you have:

- A sufficient clear space that enables you to have full range of movement required to work without risk of strain or injury
- No trip hazards (e.g. cabling, mats, clutter)
- Lighting is adequate for the tasks being performed (i.e. easy to see and comfortable on the eyes)
- Power outlets are not overloaded with double adapters and power boards
- Electrical cords are safely stowed
- Connectors, plugs and outlet sockets are in a safe condition
- Electrical equipment is free from any obvious external damage.

What resources or technology will enable successful remote learning?

- Access to a computer with internet connection.
- Ensure that their work is saved in multiple places to avoid loss if a technological issue is encountered.

Six Principles of Positive Digital Citizenship

- Respect Yourself: I will take ownership of my actions. I will select online names that are appropriate, I will think deeply about the information and images that I post online. I will consider what personal information about my life, experiences, experimentation or relationships I post. I will not be obscene.
- 2) Protect Yourself: I will think deeply about the information, images and materials I post online will not put me at risk. I will not publish my personal details or schedule of my activities. I will be courageous and report any attacks or inappropriate behaviour directed at me. I will protect passwords, accounts and resources.
- 3) Respect others: I will show respect to others. I will not use electronic mediums to bully, harass or stalk other people. I will make connections between the websites. I use and the impact they may have on my learning and the learning of other. I will not visit sites that are degrading, pornographic, racist or inappropriate. I will not abuse my rights of access and I will not enter other people's private spaces or areas.
- 4) **Protect Others:** I will be courageous and report any abuse, refrain from forwarding inappropriate materials or communications; and not visiting sites that are degrading, pornographic, racist or inappropriate. Students may wish to email their concerns
- 5) **Respect Intellectual Property:** I will request permission to use resources. I will **think deeply** about any use of websites, books, media etc. I will validate information. I will use and abide by the fair use rules.
- 6) Protect Intellectual Property: I will request to use the software and media others produce. I will use free and open source alternatives rather than pirating software. I will take ownership to purchase, licence and register all software. I will purchase my music and media, and refrain from distributing these in a manner that violates their licences. I will take ownership of my behaviour and act with integrity.

Academic support for children

Students first point of contact for any questions regarding the undertaking of remote learning is to be their classroom teacher.

If they are having difficulty, contacting the classroom teacher, they are to contact their homeroom teacher. The homeroom teacher will then make contact with the classroom teacher in order to help rectify the situation.

Students who require differentiated learning will be supported by teachers:

- remaining responsible for providing adjustments for students with additional learning needs, as reflected on SIMON by 9.00am
- cc'ing the Learning Support Officer assigned to the student in the email.

The Learning Support Leader will assign one designated Learning Support Officer as a point of contact for each student that requires differentiated learning. These staff will also communicate this with the parents.

Learning Support Officers will be available via email from 9:00am to 3.30pm Monday to Friday, during term time, to support students with the completion of differentiated learning tasks.

Students with differentiated learning needs will be supported by learning support officers:

- communicating with teachers and Key Learning Area Leaders of all the students who will require differentiated learning.
- emailing the parent of the student twice per week to check that the student is clear on the learning program and to see if there are any questions.



APPENDIX 2 Text to voice and Voice to text MAC Options

Have your Mac speak text that's on the screen

If you have trouble reading text on your screen, you can have your Mac speak the text whenever you press a key or set of keys.

- 1. On your Mac, choose Apple menu **é** > System Preferences, click Accessibility, then click Speech.
- 2. Select the "Speak selected text when the key is pressed" tick box.

By default, speaking is enabled when you press Option-Esc. To choose a different key, click Change Key, press one or more modifier keys (Command, Shift, Option, or Control) together with another key, then click OK.

3. To have your Mac start speaking, press the specified key. To stop the speaking, press the key again.

If text is selected when you press the key, the selected text is spoken. Otherwise, available text items in the current window are spoken; for example, if Mail is the current window, an email message is read.

Note: If no text items are available, you hear a beep.

Have your MAC write what you are saying

- 1. On your Mac, choose Apple menu 🏟 > System Preferences, click Keyboard, then click Dictation.
- 2. Click On. If a prompt appears, click Enable Dictation.
- 3. If asked if you want to improve Siri and Dictation, do one of the following:
 - Share audio recordings: Click Share Audio Recordings to allow Apple to store audio of your Siri and dictation interactions from this Mac. Apple may review a sample of stored audio.
 - Don't share audio recordings: Click Not Now.

If you change your mind later and want to share or stop sharing audio recordings, select or deselect the Improve Siri & Dictation tick box in the Analytics & Improvements section of Privacy preferences. See Change Privacy preferences.

Note: You can remove the audio recordings from Apple servers whenever you like — see Delete Siri and dictation history.

Dictate text

- 1. In an app on your Mac, place the insertion point where you want the dictated text to appear.
- 2. Press the dictation keyboard shortcut or choose Edit > Start Dictation.
- 3. When the feedback window shows a microphone icon \oint with a fluctuating loudness indicator, or you hear the tone that signals your Mac is ready for keyboard dictation, dictate your text.

Note: For best results, speak for no more than 40 seconds at a time.

- 4. To insert a punctuation mark or perform simple formatting tasks, do any of the following:
 - Say the name of the punctuation mark, such as "exclamation mark".
 - Say "new line" (equivalent to pressing the Return key once) or "new paragraph" (equivalent to pressing the Return key twice). After you say "new line", the dictated text appears when you're done dictating.

Set a different keyboard dictation shortcut

By default, you press the Fn (Function) key twice to start or stop keyboard dictation. If you like, you can choose a different dictation keyboard shortcut.

- 1. On your Mac, choose Apple menu **\$\$** > System Preferences, click Keyboard, then click Dictation.
- 2. Click the Shortcut pop-up menu, then choose a different shortcut.

To create a shortcut that's not in the list, choose Customise, then press the keys you want to use. For example, you could press Option-Z.
